Information about your membership by KidsLife Brussels

- KidsLife Brussels asbl informs you that you are member for a minimum of 24 months. After the first day following the 24th month of application, you may change your membership to another Child Benefits fund (Article 26, § 2 of the ordinance of April 4, 2019 establishing the payment circuit);
- KidsLife Brussels asbl informs you that the decision to change your membership will take effect on the first day of the quarter following the quarter in which the request was sent, unless that request was made during the last fifteen calendar days of a quarter. In that case, the application will only take effect from the first day of the second quarter following that of the application (Article 26, § 2, second paragraph of the Order of 4 April 2019 establishing the payment circuit),
- KidsLife Brussels asbl undertakes not to refuse the application for affiliation of a recipient of benefits, except in the cases provided for by law, nor to oppose his/her decision to change institutions (article 4, paragraph 1, 9° of the ordinance of 4 April 2019 establishing the payment circuit);
- In no case may the membership lead to benefits other than those determined by the regulations (Article 31 of the Order of April 4, 2019 establishing the payment circuit).
- For customers already receiving child benefits from KidsLife, the initial membership request remains valid. No new mandatory affiliation period will start.
